- Approval of Meeting Dates for 2022-23: The meeting dates for the upcoming fiscal year, to be held on the second Wednesday of each month at 5:00 pm, were approved on a motion by Lora Allen, seconded by Tracy Martorana, and carried unanimously.
- New Laptops for Librarians: Betsy shared a quote for 2 HP laptops to replace the librarian and director laptops. The quote was from Staples Advantage and is at NYS contract pricing. The cost for each laptop is \$1,099. The board approved the purchase of these computers on a motion made by Lora Allen, seconded by Tracy Martorana, and carried unanimously.
- Board Nominations: The nominating committee of Tracy Martorana and Lora Allen nominated
 Mary Young for president of the Library Board of Trustees, Michael Iten for vice president of the
 Library Board of Trustees, and Tracy Martorana as secretary of the Board of Trustees. These
 appointments were accepted unanimously on a motion from Lora Allen and a second from Philip
